**NOTICE OF DISMISSAL OF
NOTICE OF INTENT TO REJECT AND OPPORTUNITY FOR HEARING**

Notice is hereby given that the Ohio Attorney General's Office ("Office") hereby dismisses the Notice of Intent to Reject and Opportunity for Hearing ("Notice of Intent") that was issued on November 12, 2021 to Veterans of Foreign Wars #3283 ("VFW 3283").

The Notice of Intent stated two counts in support of the Attorney General's intent to reject VFW 3283's 2021 Bingo License Application and revoke VFW 3283's 2021 Temporary Permit to conduct bingo: (1) VFW #3283 did not meet the definition of "charitable organization" in R.C. 2915.01(H) because, as of August 2020, the Internal Revenue Service ("IRS") stopped reporting VFW #3283 as a recognized tax-exempt organization, and (2) VFW 3283 falsely stated it was exempt from federal income taxation on its 2021 Bingo License Application.

This matter having been remanded the Attorney General for further review and action, based on information that the IRS is again reporting VFW 3283 on its list of tax-exempt organizations, the Office hereby dismisses the Notice of Intent in this case.
